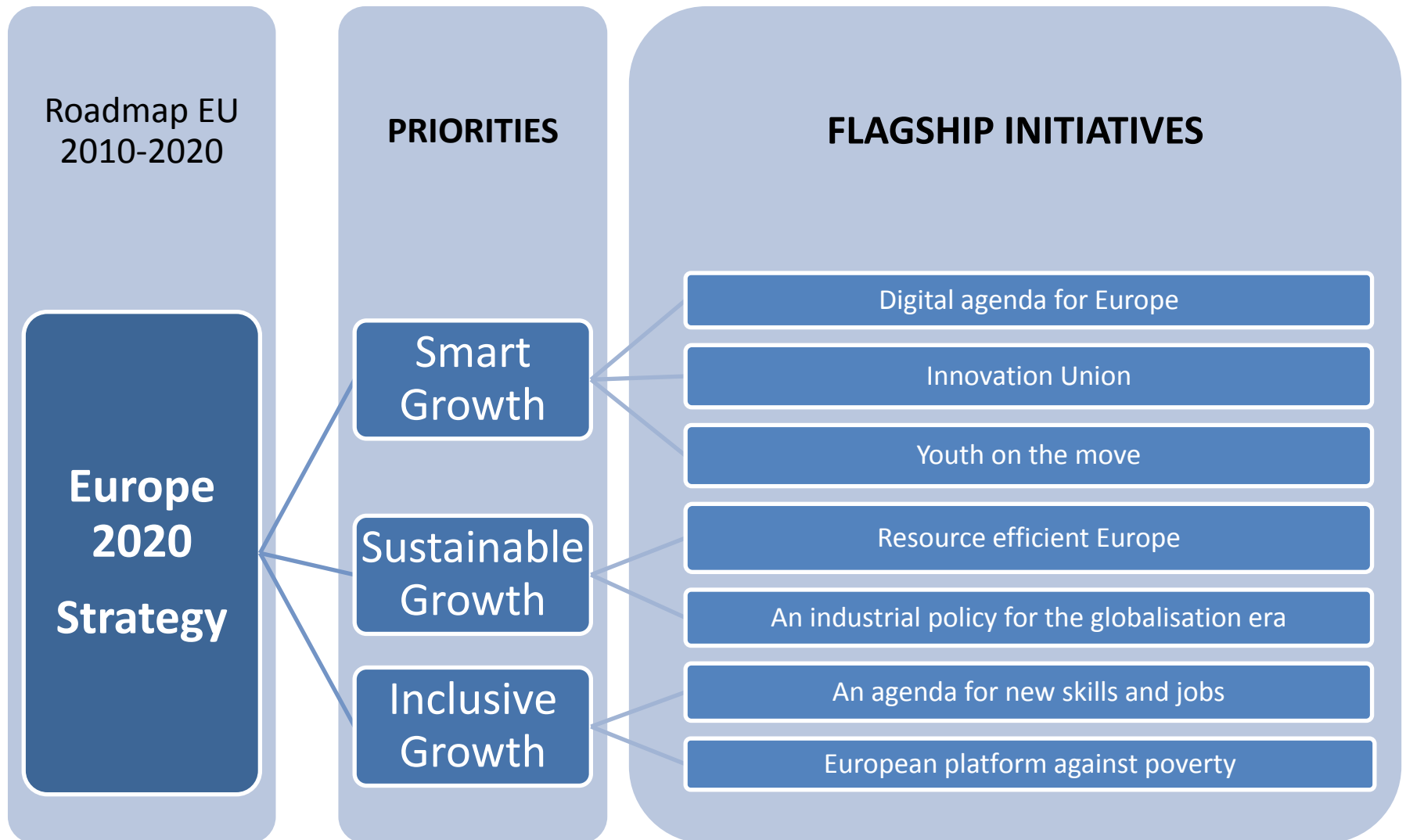

EUROPEAN TARGETS 2020

EMPLOYMENT

- 75% of the 20-64 year-olds to be employed

R&D

- 3% of the EU's GDP to be invested in R&D

EDUCATION

- reducing the rates of early school leaving below 10%
- at least 40% of 30-34-year-olds completing third level education

CLIMATE CHANGE AND ENERGY SUSTAINABILITY

- greenhouse gas emissions 20% (or even 30%, if the conditions are right) lower than 1990
- 20% of energy from renewables
- 20% increase in energy efficiency

FIGHTING PORVERTY AND SOCIAL EXCLUSION

- at least 20 million fewer people in or at risk of poverty and social exclusion

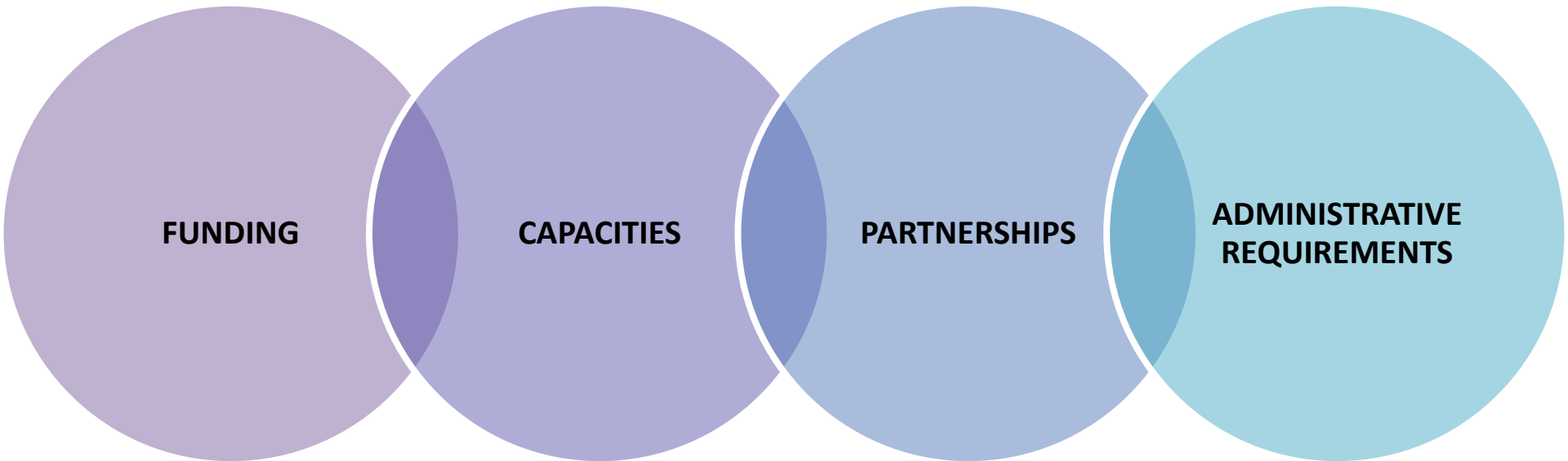
